- be able to comfortably accommodate the demands placed upon the musician's personal performance during a public concert in varying contexts
- demonstrate familiarity with various musical styles and their specific performance requirements and concert traditions
- have acquired the ability to be flexible in thought and conduct, as well as be able to adjust to new circumstances and changes
- demonstrate the capacity for musical ensemble playing in ensembles of varying sizes and in different musical styles
- demonstrate the capacity for musical ensemble playing as well as have an understanding of the fundamentals of ensemble playing
- demonstrate the ability to gather, analyse and summarise information and knowledge

The course is included in the main field of the programme, which also includes the execution of an independent project comprising 15 higher education credits.

- 2. Examination of the course takes the form of continuous assessment, at concerts or assignments. The regulations, such as prerequisites for examination and grades, are given to the students at the start of the course.
- 3. Re-examination of the course will be available soon following the original examination and have the same requirements. If the student is awarded the grade of Fail twice he/she has the right to request a new examiner. Students are permitted no more than five examination occasions.
